Additional Conditions for Consent to Operate under Air & Water Acts in respect of M/s BIOTIC WASTE SOLUTIONS PVT. LTD., 46, SSI Industrial Area New Delhi – 110033

- 1. This Consent to Operate is granted subject to the provisions of Air (Prevention and Control of Pollution) Act, 1981 as amended to date and rules and orders made thereof and under section 25/26 of the Water (Prevention and Control of Pollution) Act, 1974 as amended to date and rules and orders made thereof and based on the information provided in the consent application along with the documents submitted to this office and subsequent information / documents submitted to this office.
- The Consentee shall ensure the proper treatment and disposal of Bio-Medical Waste on its own or through an operator of Common Bio-Medical Waste Treatment Facility (CBWTF) in Delhi, authorized by Delhi Pollution Control Committee (DPCC).
- 3. The Consentee shall properly operate and maintain Eco-friendly / with inbuilt acoustic enclosure Diesel Generator Set and the Consentee control the Noise from the Diesel Generator Set to achieve the norms laid down by vide Gazette Notification of Ministry of Environment and Forest, Government of India, Dated 02.01.99, 17.05.2002 and further amendments. Adequate stack height shall also be maintained with the D.G Set (Stack height of the D.G. Set (in meters) = Height of the Building (in meters) + √KVA.
- 4. The Consentee shall take adequate measures to control the noise levels, from its own sources within the premises in respect of noise, to less than 65 Db (A) Leq during day time and 55 Db (A) Leq. During night time to meet the prescribed ambient noise standards. Daytime is reckoned in between 6 A.M and 10 P.M. and night time is reckoned between 10 P.M and 6 A.M.
- 5. The Consentee shall apply for revision / grant of Consent incase of any change or any deviation from the submitted information to this office.
- 6. This Consent is valid subject to the fulfillment of all the other statutory requirements in other Laws/Acts/Rules as applicable.
- 7. The issuance of consent shall not be construed in any manner whatsoever that the Consentee is legitimately operating your health care institution w.r.t. other statutory requirements viz-local land use, master Plane of Delhi etc.
- 8. In case of failure to comply with any of the consent conditions the consent issued to the unit shall automatically stands revoked without any notice.

Notwithstanding anything contained in this letter of consent the Committee hereby reserves to it the right and powers u/s 21(6) of the Air (Prevention and Control of Pollution) Act, 1981 as amended to date and u/s 27 (2) of the Water (Prevention and Control of Pollution) Act, 1974 as amended to date, to review anyone / or all the conditions imposed here in above and to make such variations as deemed fit for the purpose of these Acts by the Committee.
